



Memorandum of Understanding

Party B: UNIVERSITY OF MUHAMMADIYAH SEMARANG

This Memorandum of Understanding (MOU) is signed by Party A and Party B through friendly negotiations on issues of international education cooperation.

1. Taking mutual trust, mutual reciprocity and mutual benefit as the principle, both Party A and Party B shall strengthen the communication and cooperation between each other by the following means:
 - 1) Exchange and communication between teachers and students of both Party A and Party B so that to improve the sharing of teaching, research and studying.
 - 2) Both parties shall actively encourage students to participate in the programs offered for international students in each other's schools.
 - 3) Communication between research results and achievements.
 - 4) Promotion of education and cooperation in production, and academic research programs.
 - 5) Exchange of textbooks, scholar information and essays about teaching research.
 - 6) Visiting between teachers, students and administrative personnel.

The aforesaid cooperation shall be signed by both parties in advance.

2. The related expenses involved in the exchange communication, such as the expenses for round-trip tickets, board and lodging, short-term training fee, insurance and some labs and equipment engaged in the researches and so on, should be discussed with each other in advance before another formal contract is signed by both parties. In the communication, both parties will exchange visits and jointly establish the all round partnership featuring long-term stability, equality and mutual benefit.

3. This MOU shall be valid for five years from the date of signing. If any party wants to terminate this agreement, it is required to notify the other party in written form six months in advance. If there is no objection at the expiration of the contract, the contract will be renewed.

4. The amendment of the MOU shall be approved by both parties.

5. This MOU is in duplicate and each party holds one copy.

学术交流合作备忘录

贵阳护理职业学院与_____为促进两校学术交流合作关系,基于平等互惠原则,签订本备忘录。

第一条 双方同意在共同关切的领域中,藉由如下适宜的方式,推动两校交流合作关系:

- (一) 教师交流, 学生交流, 以促进双方教师与学生在教学研究或学习经验分享。
- (二) 双方应积极鼓励学生参与对方学校的留学生项目。
- (三) 教学与研究成果信息相互交流。
- (四) 推广教育, 产学合作与学术研究计划推动。
- (五) 交换教材、学术信息及教学研究等方面的论文。
- (六) 师生与行政人员互访。

上述合作事项应由双方事前另行签署备忘录。

第二条 具体交流所涉及的相关经费, 例如来回机票、食宿费、短期研修费与保险事宜, 以及从事相关研究工作、安排特殊仪器设备(实验室)等, 应由双方于事前另行签署备忘录时并同讨论。具体交流中, 双方学校应秉持平等互惠, 互相尊重, 给予等同对待; 交流人员必应遵守对方学校的相关规定。

第三条 本备忘录有效期限为五年, 自双方完成签署之日起生效, 任一方如拟终止本备忘录, 须于备忘录期满前六个月以书面通知对方, 期限届满若无异议, 则视为生效。


第四条 备忘录内容的修正, 应经由双方协商同意后方可。
