

**MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**ERICAN COLLEGE SDN BHD**  
**AND**  
**UNIVERSITAS MUHAMMADIYAH SEMARANG**

**ERICAN COLLEGE SDN BHD** (hereinafter referred to as "ERICAN"), an institution of higher learning established under the Universities and University College Act 1971 whose address at C-1-5 Megan Avenue II, Jalan Yap Kwan Seng, 50450 Kuala Lumpur, Malaysia, of the one part;

**AND**

**Universitas Muhammadiyah Semarang** which is address at Jl. Kedung Mundu Raya No. 18, Kedungmundu, Tembalang, Kota Semarang, Jawa Tengah 50273, Indonesia.

(ERICAN and UNIMUS hereinafter referred to singularly as "the party" and collectively as "the parties"),

**WHEREAS**

- A. ERICAN fulfils the need for quality training and higher education provider in developing highly skilled workforce and educated school leavers. In preparing the professional workers, ERICAN specializes in tertiary courses covering areas of business management, computer science, information technology, communication, multimedia, design, tourism, engineering, psychology, and hospitality.
- B. UNIMUS fulfils the need for higher quality education program including diploma, bachelor, profession and master (on progress) in developing highly skilled scientists, educators and professionals related to the major in their study programs. In preparing them, UNIMUS specializes of faculties and courses in areas; Medicine, Dentistry, Public Health, Nursing Science, Engineering, Economic, Humaniora, and Mathematic Science.
- C. The parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to established a basis of co-operation and collaboration between the Parties upon the terms as contained herein;

**HAVE REACHED AN UNDERSTANDING** as follows:

**ARTICLE I  
OBJECTIVE**

The Parties, subject to the terms of this Memorandum of Understanding, and the laws, rules, regulations and national policies from time to time in force, will endeavour to strengthen, promote, and develop cooperation on students' academic development and business proposition between the Parties on the basis of equality and mutual benefit.

**ARTICLE II  
AREAS OF CO-OPERATION**

1. Each Party will, subject to the laws, rules, regulations and national policies from time to time in force, endeavour to take necessary steps to encourage and promote the following areas of co-operation:
  - a) Knowledge Transfer
  - b) Short Courses and Training;
  - c) Academic and Student Exchange
  - d) Strategic marketing and promotional activities
  - e) Any other areas of co-operation to be mutually agreed upon by the Parties.

**ARTICLE IV  
EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

**ARTICLE VI  
ENTRY INTO EFFECT AND DURATION**

1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of three (3) year.
2. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the Parties.
