

**GENERAL AGREEMENT FOR ACADEMIC COOPERATION
BETWEEN
SIAM UNIVERSITY, THAILAND
AND
MUHAMMADIYAH UNIVERSITY OF SEMARANG**



Siam University, 38 Petkasem Road, Phasicharoen, Bangkok 10160, Thailand (hereinafter referred as "SU"), and **Muhammadiyah University of Semarang**, Jalan Kedungmundu Raya No. 18, Semarang 50273, Indonesia (hereinafter referred as "Unimus") hereinafter jointly referred to as Parties, and individually – Party, establish this General Agreement to foster international cooperation in education and research.

1. Both parties agree to encourage the following activities, in particular to promote international academic cooperation.
 - (a) Exchange of educational and research materials, publications, and academic information;
 - (b) Exchange of faculty and research scholars;
 - (c) Exchange of students;
 - (d) Joint research and meetings for education and research.
2. This General Agreement shall be applicable to educational and research organizations attached to each party.
3. This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or in writing, is merged in this agreement.
4. This Agreement is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship. To carry out concrete programs, the parties will conclude other agreements as supplements to the present Agreement specifying financial and juridical responsibilities.
5. This General Agreement shall become effective as of the date of signatures of both parties. The Agreement may be amended by the written consent of the parties.

6. This Agreement is in force for five years. The Agreement may be extended for additional five-year periods upon the written consent of both parties. In such case this Agreement should be reviewed to evaluate the progress and the quality of the mutual cooperation. If the Agreement is not renewed by mutual consent, the Agreement will conclude at the end of the specified time period, or after activities in progress have concluded.
7. This Agreement may be terminate by either party with a minimum of 120 days written notice. Activities in progress at the time of termination of this Agreement shall be permitted to conclude as planned unless otherwise agreed.
8. Each party shall designate a person or office to serve as liaison for implementing this Agreement. For Siam University, the contact will be Ms. Yhing Sawheny, Assistant Directors for International Affairs, email yhing@siam.edu. For Muhammadiyah University of Semarang, the contact will be Mr. Muhammad Yusuf, the Director for International Affairs and Cooperation, email m.yusuf@unimus.ac.id.
