### WITNESSETH:


WHEREAS, the FIRST PARTY and SECOND PARTY have the Intention of establishing educational partnership between their institutions.

WHEREAS, the FIRST PARTY and SECOND PARTY have consented to enter into a joint agreement to undertake mutually-beneficial programs, projects, and activities within and outside the campuses of each of the parties.

NOW, THEREFORE, the PARTIES hereto mutually agree on:

1. Regular exchange of visits of officials and other personnel of the parties in their various campuses.
2. Faculty and student mobility and exchange between the parties.
3. Adoption of an international curricula that is responsive of the ASEAN Integration concepts.
4. Engagement in collaborative research and community development undertakings especially on the flagship disciplines of the parties.
5. International service learning in the countries of the parties.
6. Other linkages in the field of cultural, literary, sports, and other productive endeavors.
7. Encourage other universities to join in the academic partnership or engage in joint ventures.
8. The SECOND PARTY will only conduct activities or undertakings which are in full compliance to the rules, regulations, and policies of the Commission to Higher Education (CHED) and other appropriate government agencies of the Philippines.
9. All financial agreements will have to be negotiated and agreed upon with due regard to the availability of funds and other resources.
10. Both parties agree that there will be a specific subsidiary contract in writing for each particular project or undertaking.






