KNOWN ALL MEN BY THESE PRESENTS:

Sichuan Medical University, was founded in 1951 and is a government university recognized by both the Chinese government and the World Health Organization with principal office at No.99, Haike Road, Eastern Section, Wenjiang District, Chengdu, Sichuan, P.R. China. Zip Code 611130, hereinafter referred to as Sichuan Medical University and represented in this instrument by its Director of International Office, ZangXilin

and

University of Muhammadiyah Semarang is one of the private higher education institution duly given permission by Ministry of Research, Technology and Higher Education of the Republic of Indonesia, with principal office at Jalan KedungMundu Raya No 18 Semarang, Indonesia, here in after referred to as University of Muhammadiyah Semarang and represented in this instrument by its Director of International Office, Muhammad Yusuf

and

SEAMEO Regional Open Learning Centre duly organized under the Southeast Asian Ministers of Education Organization (SEAMEO), with principal office at Kompleks Universitas Terbuka, Jl. Cabe Raya, Pondok Cabe 15418, Jakarta, Indonesia, hereinafter referred to as SEAMEO SEAMOLEC and represented in this instrument by its Director, Dr. Abi Sujak M.Sc

WITNESSETH

WHEREAS, Sichuan Medical University was founded in 1951 and is a government university recognized by both the Chinese government and the World Health Organization

WHEREAS, SEAMEO SEAMOLEC is a Regional Centre for training and human resource development, research and development, information technology and consulting in the field of open and distance learning;

WHEREAS, University of Muhammadiyah Semarang is a higher learning institute duly registered as an education institution, was established based on the Ministerial Decree of the Minister of Education and Culture No. 139/D/O/1999. The university is a full-time institution of normal education, offering various undergraduate courses.

WHEREAS, Sichuan Medical University, University of Muhammadiyah Semarang and SEAMEO SEAMOLEC have complementary objectives and a mutual desire to collaborate in a number of areas to pursue common educational development. In consideration of the above premises and covenants hereunder provided, both parties to this Memorandum of Understanding (MoU) agree as follows:

1. To collaborate in undertaking programs, projects, and other related activities whenever and wherever feasible opportunities present themselves.
2. To exchange scientific materials, publications, and information.
3. Cooperation in the field of research.
4. Online Collaborative Teaching and learning (Digital Class)
5. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by both parties.
6. Development of Joint courses and education programs
7. To conduct Joint Research, International Seminar, Conference, Symposium and Workshop.

This Memorandum of Understanding takes effect upon signing by the authorized representatives of both institutions, and remains in force for a period of 3 (three) years, subject to amendment at any time by mutual consent. The said agreement shall be extended for an additional period of 3 (three) years at each expiration date, unless either party gives written notice to terminate the agreement at least six months prior to the expiration date.

Memorandum of Understanding

In order to promote mutual understanding and expand common educational and academic research cooperation programs, both parties have reached the following agreement after thorough discussion:

- I, Encourage academic exchanges and cooperation between teachers and departments of both parties.
- II, Invite teaching staff and students of both parties to engage in academic lectures and seminars, visit.
- III, Invited each other to participate in academic seminars and other professional and academic conferences.

The implementation details of the MOU will be negotiated by both parties according to a specific project. The MOU shall remain in force for two years after signed by the representatives of both parties. Any modification or termination of the MOU shall be agreed by both parties. Any party wishes to terminate the MOU shall notify the other party in writing form six months in advance.

If both parties have no objections, the validity of the MOU is automatically extended when it expires.
